
The Authority shall be responsible to coordinate with various departments at the State Level and shall have advisory role in the matters of planning development, regulatory control and management of the special area. The Chief Executive Officer of the Authority shall be responsible to run the day to day functions of the Authority and shall also perform the functions of section 70 for Nalagarh and Baddi- Barotiwala Special Area except functions under Section 70 (vi) for the entire area. Also Chief Executive Officer shall not perform the functions under Section 70 (v) and (vi) for the areas of Municipal Council Nalagarh and Nagar Panchayat Baddi.
